At the outset, the Registrar and the Member Convenor of the above Committee extended warm welcome to all the Members who were present in the meeting. Thereafter, the Registrar requested the Director of Education to chair the meeting, and reviewed the objections received against the provisional eligible and not eligible list of the candidates for the posts of the **Service Personnel and the Programme Assistant (Lab Technician)** at UHS, Bagalkot published by the University in the website vide its Notification dated 06.01.2023 (Advt. No. 14). The candidates aggrieved by the list of the eligible and non-eligible for the posts were given time up to 15.04.2023 for submitting their objections, if any, in this regard.

Further, the aforesaid Committee discussed the objections in-depth individually received from the candidates for the posts of the **Service Personnel and the Programme Assistant (Lab Technician)** at UHS, Bagalkot, and gave its recommendations as detailed below.

The Committee reviewed the representations made by the candidates and not considered their requisitions as these candidates have failed to submit their relevant documents along with their applications within the last date set by the University for the receipt of the application.
2)	ADIYAVVA CHANDRAPPA SUTAGATTI (APPL. No. 188) DRIVER (LV)	Requested to consider the Experience Certificate	
3)	SIDDARAJU D. (APPL. NO. 146) DRIVER (LV)	Requested to consider the 7 th qualification for eligibility.	The Committee not considered the request of the candidate, since he has not possessed educational qualification of SSLC, which is the essential qualification for the post of Driver (LV) as per the University notification.

4)	IRAPPA TALAWAR S/O HANAMANTAPPA (APPL. No. 43) SUPPORTING STAFF (GARDENER)	Requested to consider the Training of 8 months equivalent to 10 months training.	As per the recruitment notification the essential training to become eligible for the post of the Gardener is 10 months duration, but the candidate has completed 8 months duration training. Hence, the Committee has not considered the request of the Candidate.
